## REPORT ON THE BEGINNING OF INTERNSHIP FOR B.ED SEMESTER 3 PUPIL TEACHERS

**Duration:** August 01 to November 30, 2024 **Institution:** GHG Khalsa College of Education, Sadhar **Overview:** The internship program for B.Ed Semester 3 pupil teachers commenced on August 01, 2024, and will continue until November 30, 2024. This essential phase of teacher training aims to provide practical teaching experience to future educators, aligning with the pedagogical practices and theoretical knowledge they have acquired during their coursework.

**Allocation of Teaching Practice Schools:** Prior to the commencement of the internship, pupil teachers were given the opportunity to express their preferences for teaching practice schools via a Google Form. This approach ensured that the placements were aligned with the students' convenience and interests, enhancing their overall internship experience.

**Preparation Phase:** A comprehensive two-week preinternship and skill enhancement program was conducted on the college campus to prepare the pupil teachers. This phase included workshops, mock teaching sessions, and various activities designed to hone their teaching skills and equip them with the necessary tools to excel in a real classroom environment.

**Initial School Visits:** On August 1 and 2, 2024, teacher educators from GHG Khalsa College of Education, Dr. Rachhpal Singh and Dr. Manpreet Kaur, visited the allocated schools. The objectives of these visits were multifaceted:

- Settling Pupil Teachers: Ensuring that pupil teachers were comfortably integrated into their respective schools.
- Interaction with School Principals: Establishing a rapport with the principals to discuss the internship program and address any preliminary concerns.
- Assignment of Mentors: Coordinating with school authorities to assign experienced school teachers as mentors for the pupil teachers.
- Acquainting School Authorities: Informing the school staff about the specific requirements and expectations for the smooth conduct of the internship program.

**Roles and Responsibilities:** Dr. Rachhpal Singh and Dr. Manpreet Kaur, as the in-charges of the internship program, have been pivotal in organizing and overseeing the entire process. Their responsibilities include:

- **Real-life Examples:** The session featured real-life examples and case studies to illustrate financial concepts and best practices, making the content more relatable and understandable.





Teacher educators from the college visited various schools where pupil teachers have been placed for their internships. The primary objectives of this supervision phase were to observe the teaching performance of the interns, assess the quality of their lesson planning, and gather feedback from the school authorities and mentors regarding the interns' progress.

#### **Objectives of the Supervision**

- 1. **Classroom Observation**: To observe the pupil teachers while they delivered lessons, focusing on their teaching methodologies, classroom management skills, and student engagement.
- 2. **Evaluation of Lesson Plans**: To check and review the lesson plan files maintained by the interns, ensuring that they align with pedagogical standards and reflect sound planning.
- 3. Feedback from School Authorities: To meet with school heads and mentors assigned to the interns in order to gather feedback on their professional growth, attitude, and performance during the internship period.

#### Activities Conducted During the Supervision

#### 1. Classroom Teaching Observations:

- Teacher educators closely monitored the interns as they conducted their lessons. Particular attention was given to the clarity of concepts presented, the use of teaching aids, the ability to maintain discipline, and the overall effectiveness of the lesson delivery.
- Constructive feedback was provided to the interns after their lessons, highlighting areas for improvement and appreciating their strengths.

#### 2. Lesson Plan Evaluation:

- The lesson plan files of each intern were thoroughly reviewed. Teacher educators checked for completeness, logical sequence, and alignment with learning objectives. The use of innovative teaching strategies and assessment techniques was also examined.
- Suggestions were given to improve lesson planning, especially in terms of integrating more studentcentered approaches and diversified activities.

#### 3. Meetings with School Authorities and Mentors:

- Teacher educators met with the school heads and mentor teachers who have been guiding the interns during their practice teaching. These discussions provided valuable insights into the interns' professionalism, punctuality, communication skills, and willingness to learn.
- The feedback received was largely positive, with school authorities appreciating the college's initiative in preparing well-rounded teacher trainees. Some areas for improvement, such as enhancing classroom control and adapting to diverse learning needs, were identified and communicated to the interns.





#### **Key Findings**

#### Strengths Observed:

- Interns demonstrated confidence in lesson delivery and showed significant growth since the initial phase of their internship.
- Effective use of teaching aids and innovative instructional strategies was observed in several classrooms.
- School mentors reported that most interns are proactive, punctual, and eager to learn.

#### Areas for Improvement:

- Some interns need to work on managing larger classrooms and maintaining consistent student engagement.
- There is a need for better differentiation in teaching to cater to the diverse learning needs of students.
- A few interns require additional guidance in structuring their lesson plans to ensure a clear flow of content.

#### **Conclusion and Recommendations**

- Regular follow-ups be conducted to monitor the progress of the interns as they implement the suggestions provided during this supervision phase.

The college's commitment to providing continuous support and guidance is evident through such structured supervision phases, contributing significantly to the professional development of its student teachers.
